

2) The following goods, produced in Angola, shall be admitted free of duty when imported into the territory of Rhodesia:

Bananas, fresh or green.
Beans, dried or split.
Fish, dried.
Fish, frozen.
Fish meal.
Groundnuts, shelled or unshelled, but not otherwise prepared.
Marble, in the rough or sawn, including chips.
Oil-seeds, in bulk, excluding copra.
Petroleum, crude.
Pineapples, fresh or green.
Salt, common, in bulk.
Sisal fibre.
Wood, in the rough, rough-sawn in the length or block and logs, excluding coniferous or eucalypt species.

3) The following goods, produced in Rhodesia, shall be admitted free of duty when imported into Angola:

Animals, live, for breeding purposes.
Asbestos, raw.
Chicks, day-old.
Coal and coke.
Seeds for planting.

ARTICLE VII

The parties, having regard to the objectives of this Agreement, and recognising that problems may arise in their attainment, agree that:

- (a) a party which proposes to take or authorize action which it considers may affect any benefit accruing to the other party under this Agreement shall, wherever possible, consult in advance with, and give sympathetic consideration to any representations made by, or proposals received from, the other party; and
- (b) a party shall be free at all times to approach the other party for consultations with a view to finding ways and means to solve any difficulties or problems arising in their trade or economic relations; and
- (c) to facilitate the consultations envisaged in paragraphs (a) and (b) above, and the consideration of any requests or representations made by one party to the other in terms of Article IV, there shall be established a permanent joint trade and economic liaison committee, consisting of representatives of both parties.

The committee established in terms of paragraph (c) above will be entrusted with the task of examining any questions raised by either party relating to the implementation of this Agreement and any amendments or comple-

mentary matters which developments in the trade between the parties, or in their respective economies, may suggest.

The said committee shall, if practicable, meet quarterly and whenever either party may require it to meet.

The place and date of these meetings will be determined by common agreement between the members of the said committee.

ARTICLE VIII

This Agreement shall come into operation on the 1st April, 1965, and shall remain in force for an initial period of five years from that date, and, unless notice of termination is given by one party to the other party six months before the expiry of that period, it shall thereafter remain in force until the expiry of six months from the date on which notice of termination is given.

On the coming into operation of this Agreement, the provisions of all former agreement relating to trade between the territories of the parties shall cease to have force or effect.

Done at Salisbury in duplicate, in Portuguese and in English texts, each of which shall be of equal authenticity, on this 24th day of February, one thousand nine hundred and sixty five.
